Call for Artists

Summer Show July 4 – August 24, 2012

All work to reflect images/influence of the Mission Statement of the Coastside Land Trust (CLT): “Dedicated to the preservation, protection and enhancement of the open space environment including the natural, scenic, recreational, cultural, historical, and agricultural resources of Half Moon Bay and the San Mateo County coast for present and future generations.”

All medium is invited to be considered.

CLT will arrange the show and have final say in the placement of artwork. CLT will coordinate advertising and marketing of this show, including announcements sent to its donor database (2,000+ individuals).

All exhibited work will be available for sale. CLT, as the artist’s representative, will retain a 30% commission on any work sold. Work should be priced by the artist to include the 8.25% California Franchise Tax, as the work will be sold “with sales tax included” in the price. Sold work may be taken by the purchaser on date of purchase; however, the art may be replaced by the artist with a suitable, consistent piece of art (to be approved by CLT prior to being hung).

The attached application and art entries must be submitted to CLT starting May 28 and received no later than June 4, 2012. As part of the application process, at least two but no more than four digital images shall be emailed to CLT at < info@coastsidelandtrust.org >

- You may submit entries for a minimum of two and a maximum of 4 pieces of work. Digital photographs of your art are to be emailed separately to info@coastsidelandtrust.org > Identify your name and the works in the email and limit file size to 6 MG (Jpeg format).
- Work must be ready to hang with picture wire and screw eyes or D-rings.
- Work is to be 36" or less in both height and width.
- Work weighs 20 lbs or less.
- Artist to provide stand for sculpture.
- Work is to be labeled on the back (artist, title, medium, size and price).
- Work to be original and not hung in any prior CLT shows during 2012.

- Upon acceptance to exhibit, a fee of \$15 per entry will be payable at delivery.
