Call for Artists

California Agriculture Show

Submission Period: June 29 – July 5
Show Dates: August 14 – October 23

Since 1997, Coastside Land Trust has actively worked to protect and enhance the natural, scenic, recreational, cultural, historical, and agricultural resources of Half Moon Bay and the San Mateo County coast. Our gallery was launched in 2011 to convey the beauty of these resources through art. We now hold four to six thematic, juried shows per year and all artists are invited to submit. Coastside Land Trust Gallery is located at 788 Main Street in downtown Half Moon Bay.

This show will contain images from or inspired by **agriculture in California**. California's diverse landscapes, microclimates, and soils support a wide variety of crops and livestock. As the top producing state in the nation, agriculture in California provides a foundation for our health and economy, and is part of our history and cultural identity. Coastside Land Trust Gallery hopes to capture these elements in its upcoming show, **"California Agriculture"**. Examples of images that will be considered are: crops, orchards, livestock, farm and ranch equipment, and agriculture landscapes and buildings. All media is invited to be considered.

The show will run through the Half Moon Bay Art and Pumpkin Festival on October 17th and 18th.

To apply to the show, please read the application instructions, then fill out, sign, and return the one page Application to Exhibit included below.

Application Instructions and Parameters of Work

- Digital photographs of your work must be emailed to info@coastsidelandtrust.org
- Identify your name and the titles of your works in the email (JPEG format).
- Please submit at least two and no more than four pieces of work.
- Work must be ready to hang with picture wire and screw eyes or D-rings. Work must be “gallery-ready” in appearance and finish. Work that is not gallery ready in appearance and finish will be turned away at the time of drop off.
- Work is to be 42” or less in both height and width (total perimeter size not exceed 42” x 42”)
- Work weighs no more than 20 lb.
- We recommend installing museum glass to minimize glare from lights and windows
- Work is to be labeled on the back (artist, title, medium, size and price).
- Work to be original and not hung in any prior CLT shows for the previous year.
- Upon acceptance to exhibit, **a fee of \$20 per entry** will be payable at delivery.

Show Arrangement and Conditions of Sales

- CLT arranges the show and has final say in the placement of work. CLT will coordinate advertising and marketing of this show. Announcements (8,000+) will be sent to CLT’s donor database, posted in the HMB Review, and delivered to businesses throughout the coastside.
- All exhibited work will be available for sale. CLT will retain a 30% commission on any work sold. Work should be priced by the artist to reflect a pretax amount (the 9.5% sales tax will be *added* to the price and collected at time of sale). **The price listed on the application is final and is not subject to change.** The purchaser may take sold work at time of sale.
- **All notecards must be sold at \$4.57 plus tax**, all other sale prices are determined by the artist. A maximum of 30 notecards can be accepted per artist per show. Additional matted works and notecards that fit the theme of the show will be accepted.
